This course is designed to provide participants with the knowledge and skills to verify the data accuracy of EPAF transactions and approve them in a timely manner.

In a computer lab, participants will experience a leader-led, hands-on learning event targeted for individuals who will become EPAF Approvers, Proxies, and FYIers.

- Explain the EPAF process and timing of the Apply Cycle.
- Describe the roles of EPAF Approver and EPAF FIYer.
- Access the EPAF Approver's Summary Page to monitor EPAF activity.

- View authorizing and supporting electronic documentation using ApplicationXtender.
- Verify accuracy of EPAF transaction data by comparing the transaction with the electronic documentation.
- Return EPAF transactions with data errors to the EPAF Originator for correction and re-submittion.
